# **Article 1 - DEFINITION, ACTIVITY AND PURPOSES**

- a) The Viana do Castelo Regional Scout Group promotes from July 28th to August 2nd, 2024 the 6th Viana do Castelo Regional Camp (hereinafter referred to as ACAREG 2024) under the imaginary "Planet Earth Mission" under the motto "Make a difference."
- b) ACAREG 2024 aims to
- Be, from preparation to completion, a reference activity in the scouting career of each participant, providing a set of educational opportunities that can contribute to the personal progress of young people;
- Provide all participating scouts with the experience of the scouting ideal proposed by the CNE (Scouts for Portugal) Educational Program, structured according to the Patrol System and in accordance with the CNE educational methodology, oriented towards raising scouts' awareness of respect, conversation and promotion of values of Nature;
- Promote unity and sharing among all participants;
- Provide unique educational opportunities, in the progress of each participant;
- Promote the various areas of development of young scouts in order to ensure correct integration into their socio-cultural environment, through the use of the technical and pedagogical resources of the scouting educational project;
- Contribute to the integral formation of young people, through actions that highlight human and Christian values, namely Autonomy, Equality, Humility, Freedom, Respect, Friendship, Fraternity, Tolerance, Solidarity, Responsibility and Perseverance;
- Offer an opportunity for pedagogical and organizational field training for participating leaders and candidate leaders;
- Strengthen the image of the National Listening Corps in the Viana do Castelo Region, as an educational proposal leading to the integral development of Youth.

#### **Article 2 - ORGANIZATION**

- a) ACAREG 2024 takes place in the Paços de Giela, Arcos de Valdevez, Portugal, <a href="https://maps.app.goo.gl/Q5TXMqMZ6mis3hGt8">https://maps.app.goo.gl/Q5TXMqMZ6mis3hGt8</a>
- b) ACAREG 2024 will start on July 28, 2024 (Sunday) and end on August 2, 2024 (Friday)
- c) The Camp will be divided into four Subcamps, 1st section (wolfs, 6 to 10 years), 2nd section (explorers 10 to 14 years), 3th section (Pioneers, 14 to 18 years) and 4th section (Hikers 18 to 22 years) and a set of services essential to the proper functioning of camp life.



- d) Participants must enter the field between 9:00 am and 12:00 pm on July 28th (with the lunch meal being the responsibility of the participants).
- e) The exit of the field will take place from 5pm on August 2nd after the ACAREG 2024 closing ceremony.
- f) Participants registered for services must enter the field from 8:00 pm on July 26, 2024 (Friday), with meals being provided from breakfast on Saturday.
- g) Participants registered for services must leave the field during the morning of August 4, 2024 (Sunday), with meals guaranteed until breakfast on Sunday.
- h) ACAREG is aimed at 1st section (wolfs, 6 to 10 years), 2nd section (explorers 10 to 14 years), 3th section (Pioneers, 14 to 18 years) and 18 to 22 years) with no limit on the number of participants.
- i) Leaders and IST will be integrated into the various field services.
- j) The Acareg Leader will be allocate Leaders and IST for the necessary services in the field, considering the preferences indicated by them at the time of registration and their scouting, technical and professional experiences.
- k) The Acareg Leader may invite, for specific tasks in the Camp, entities, or individuals outside the Movement.

#### **Article 3 - PARTICIPATION CONDITIONS**

- a) Only Scouts who have scouting experience and adequate technical preparation can participate in ACAREG, which is why we have established the following participation criteria:
- b) Only Scouts whose investiture in the respective Section has been made by June 30, 2024 will be able to participate;
- c) The participation of Scouts under 18 years of age is also dependent on the written authorization of parents or guardians, and the Group Leader is responsible for guaranteeing this requirement;
- d) All participants in ACAREG2024 must be registered in the SIIE (Integrated Scouting Information System) and their health record updated until the moment of final registration, which can be updated later, in case of medical need;
- e) Registration will be open to scouts from other regions;



#### **Article 4 - REGISTRATION CONDITIONS**

- a) Registration for ACAREG 2024 will be made through SIIE.
- b) Registration of participants will be carried out by the group, which must organize its contingents taking into account the following proportions:
- c) Each group of wolfs must have between 4 and 7 members
- d) Each group of explores / pioneers and rovers must have between 4 and 8 elements
- e) The registration of a Leader for each band, patrol, teams and tribes registered is mandatory;
- f) In the case of a pack, and when registering a single group in the group, two adults are permitted to register to accompany the group, one of whom must be a vested leader.
- g) Rovers will be able to form multi-group tribes to reach the minimum number of participants.
- h) In the case of sections of wolfs, explorers and pioneers and in cases where there is not the minimum number of registered members in a section of the group, these elements may join another group, with their registration being attached to the group that receives them.
- i) Only individual registrations for services will be accepted, IST.
- j) The registration of all Leaders will be done individually in the forms until 1<sup>st</sup> June, 2024. In this registration, they will be asked to order the list of services in which they intend to collaborate.

# **Article 5 - REGISTRATION AND PARTICIPATION COSTS**

a) The registration and payment plan is defined in the table below:

- b) By 1st of June, 2024, the group will have to complete the final registrations of all elements (by bank transfer) and it will be necessary to provide the nominal list of participants included in the respective group.
- c) After 1st of June, 2024, only nominal changes and within the same band/patrol/team/tribe will be permitted.
- d) Payments will be made to the Regional Group of Viana do Castelo by bank transfer, after sending the invoice to the group.
- e) Registration entitles you to participate in ACAREG 2024, badge, participant kit, registration for all activities as well as meals between dinner on July 28, 2024 and lunch on August 2, 2024

#### **Article 6 - COUNTRY LIFE**

- a) In addition to the general activities (Opening Ceremony, Sunday Eucharist, Field Party and Closing Ceremony), activities will be carried out based on the Sections and subfields.
- b) Any definitive departure can only occur after express written authorization from the Field Chief.
- c) The sale of any Scouting items, can only be done in specific locations and with authorization from the Acareg Leader.
- d) The guiding rules for life in the field will be published in a timely manner in a guide created for this purpose.
- e) The uniforms to be used at each stage of ACAREG 2024 will be defined and published in a timely manner by the Acareg Leader.

#### **Article 7 - FINAL DISPOSITIONS**

a) By registering for ACAREG 2024, participants authorize the processing of their voice and/or image data captured during ACAREG 2024, granting the rights to the CNE / Junta Regional de Viana do Castelo for five years, free of charge and without the need for prior consultation on the forms of use, the CNE / Regional Scout Group of Viana do Castelo always acting in good faith and in accordance with its Law and Principles. The purpose of the processing is the historical archive, the promotion and dissemination of projects, events and activities promoted and/or organized by the CNE / Junta Regional de Viana do Castelo in the various means of communication available, namely on



posters, flyers, merchandising products exclusive, social networks, websites, television, radio and other equivalents.

- b) Disciplinary issues will be resolved according to the scouting method and in accordance with the CNE Justice Regulations, with their resolution ultimately being the responsibility of the Acareg Leader.
- c) For situations whose seriousness requires the application of a higher sanction, the Field Chief may forward the respective decision to the Regional Board.
- d) The organization and operation of ACAREG 2024 will follow the specific organizational chart to be published in due course.
- e) Any situations not covered by this regulation will be resolved by the Acareg Leader.
